

## **GIPPSLAND BROADBAND – PRIVACY POLICY**

This Privacy Policy sets out Mosoti Pty Ltd trading as Gippsland Broadband ABN 44 613 087 791 its successors and assignees (referred to as **we, us and our**) commitment to protecting the privacy of your personal information that we collect through this website [www.gippslandbroadband.com.au](http://www.gippslandbroadband.com.au) (**Site**) or directly from you, being the person, organisation or entity that uses our Site (referred to as **you or your**).

Please read this Privacy Policy carefully. Please contact us if you have any questions – our contact details are at the end of this Privacy Policy.

You providing us with personal information indicates that you have had sufficient opportunity to access this Privacy Policy and that you have read and consented to it.

If you do not wish to provide personal information to us, then you do not have to do so, however it may affect your use of this Site or any products and services offered on it.

### **1. Collection of personal information**

**Personal information:** The type of information we collect may include:

- name;
- contact details including email address, address and telephone number;
- marital status and anniversary;
- date of birth;
- drivers licence number and expiry;
- demographic information such as postcode;
- preferences and opinions;
- payment details; and
- any other information requested on this Site or otherwise requested by us or provided by you.

**Your use of our Site:** As with most online businesses, we may log information about your access and use of our Site, including through the use of Internet cookies, your communications with our Site, the type of browser you are using, the type of operating system you are using and the domain name of your Internet service provider.

**Your opinion and feedback:** We may contact you to voluntarily respond to questionnaires, surveys or market research to seek your opinion and feedback. Providing this information is optional to you.

If we receive your personal information from third parties, we will protect it as set out in this Privacy Policy.

### **2. Collection and use of personal information**

We collect and use the information for purposes including:

- to contact and communicate with you;
- for internal record keeping;
- for market research and business development including website development;
- for marketing including direct marketing;
- to run competitions or offer additional benefits to you;
- to send you promotional information about third parties that we think may be of interest to you; and
- for data analytics purposes.

### **3. Disclosure of personal information to third parties**

We may disclose personal information to:

- credit reporting agencies and courts, tribunals and regulatory authorities where customers fail to pay for goods or services provided by us to them;
- courts, tribunals, regulatory authorities and law enforcement officers as required by law, in connection with any actual or prospective legal proceedings, or in order to establish, exercise or defend our legal rights; and
- third parties to collect and process data including Google Analytics.

Where we disclose your personal information to third parties for these purposes, we will request that the third party follow this Privacy Policy regarding handling of your personal information.

If there is a change of control of our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible by law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser. We would seek to only disclose information in good faith.

#### 4. Credit Information and Reporting - Part 3A of the *Privacy Act 1988* (Cth) (Privacy Act)

We may collect personal information from you to enable us to do a credit check when you apply for some products and services we offer, including but not limited to: your full name, date of birth, home address, any previous address, employer information, relevant personal details.

We will collect your credit information via our website, application and our services.

We will use the credit information you provide to seek a credit report from a credit reporting agency with your consent. We will collect, hold, use and disclose credit information to assess which products and services you can purchase from us and to provide ongoing services to you.

We will not use or disclose credit information for direct marketing purposes, however we may use it to pre-screen our marketing lists. You may make a request for us to not to use your information for pre-screen purposes.

You may access the credit reporting information held about you and seek the correction of such information including personal credit information about you, credit reporting body derived information about you or credit provider derived information about you. You may also request a correction in relation to the credit information. If we cannot be satisfied of a matter relating to the correction of credit information we must consult another interested party about your request, and we may disclose your information to do this.

You will not be charged by us for making a request in relation to credit information or correcting credit information. You may make a complain as specified below if you believe we have breached our obligation to you regarding your personal credit information.

#### 5. Your rights and controlling your personal information

**Choice and consent:** Providing us with your personal information is optional to you. You can choose not to provide personal information. When you provide us with your personal information, you consent to the terms in this Privacy Policy, and to us disclosing or receiving your personal information for these purposes.

**Your provision of third party information:** If you provide us with third party personal information then you warrant to us that you have the third party's consent to provide this.

**Restrict:** You may choose to restrict the collection or use of your personal information. If you have previously agreed to us using your personal information for direct marketing purposes, you may change your mind at any time by contacting us at the email address listed in this Privacy Policy.

**Access:** You may request details of personal information that we hold about you, in certain circumstances set out in the Privacy Act. An administrative fee may be payable for the provision of information. We may refuse to provide you with information that we hold about you, in certain circumstances set out in the Privacy Act.

**Correction:** If you believe that any information we hold about you is inaccurate, out of date, incomplete, irrelevant or misleading, please contact us by email. We rely in part upon customers advising us when their personal information changes. We will respond to any request within a reasonable time. We will endeavor to promptly correct any information found to be inaccurate, incomplete or out of date.

**Complaints:** If you believe that we have breached the Australian Privacy Principles and wish to make a complaint about that breach, please contact us by email setting out details of the breach. We will promptly investigate your complaint and respond to you in writing setting out the outcome of our investigation, what steps we propose to take to remedy the breach and any other action we will take to deal with your complaint.

## 7. Cookies & Web Beacons

We may use web beacons on this Site from time to time. Web beacons or clear.gifs are small pieces of code placed on a web page to monitor the visitors' behaviour and collect data about the visitors viewing a web page.
